DEPARTMENT OF CULTURAL AFFAIRS ANNOUNCES CREATIVE CATALYST ARTIST FOR 2019-2021 RESIDENCY

Los Angeles - The City of Los Angeles Creative Catalyst Program, part artist residency, part urban transportation lab space, embraces art as social practice to help achieve Mayor Garcetti's Vision Zero goal to eliminate traffic fatalities by 2025. The Department of Transportation (LADOT) and the Department of Cultural Affairs (DCA) have worked in partnership to support this initiative and to select the artist who will be in residence at LADOT and will have 24 months to develop ideas and produce creative interventions in support of Vision Zero.

The artist selected for the 2019-2021 residency is Renée Reizman. Reizman will work collaboratively with LADOT and local communities to challenge existing ideas around transportation in Los Angeles. Together they will work to develop projects that encourage compassion and empathy on our streets, and reimagine a transportation system that allows all of us to travel safely and with dignity, whether you are a person walking, rolling, bicycling, scootering, taking public transit, or driving a car.

Reizman's artistic practice and approach have readied her for this role. A recent graduate of University California Irvine, Reizman earned a Master's of Fine Art with a focus on Critical and Curatorial Studies. Reizman, who also has a background in film production, felt compelled to leave Hollywood when her artwork began to lean towards more conceptual ideas that looked towards the urban landscape. Creatively, she began to focus on systems, regulations, public policy, and laws. Reizman says, "My artwork is often collaborative so that it can be educational and represent a diverse set of perspectives. It is also site-specific, responding to the history and laws that shaped the infrastructure or environment. It is a mix of social practice, creative placemaking, installation, and writing."

For this artist, the appeal of the Creative Catalyst Program was a hope that the program would, "...finally give me a formal environment in which to research a branch of city infrastructure, support, and expertise from city employees, and the potential to critique and transform the bureaucratic culture from within. I'm really excited that LADOT is open to having an artist influence their ambitions," said Reizman.

The Creative Catalyst will have the opportunity to engage in conversations that can lead to action and change in the community. The goal of the program is to shift public behaviors through the use of innovative dialogue and projects. Selected through a community-driven process developed by DCA and contracted to work within DOT as a part-time consultant/contractor for a period of 24 months, the Artist-in-Residence will receive a \$52,000 stipend per year.

"The Department of Cultural Affairs is excited to partner with DOT for the second iteration of the Creative Catalyst Program and support the Mayor's Vision Zero Initiative. This new take on the Artist-in-Residence model is an opportunity for artists to function as social practitioners within a city agency and I am confident that our selected artist will bring a fresh approach and set of creative solutions to our government culture and process," said Danielle Brazell, General Manager Department of Cultural Affairs.

"Art is a powerful tool to inspire, motivate, and challenge common perceptions about the world around us," said LADOT General Manager Seleta Reynolds. "To meet our ambitious Vision Zero goals, and create the safe and livable streets Angelenos want, we are thinking differently about how we plan our streets and engage with people. We are grateful to have Renée joining the Vision Zero team, bringing her experience and fresh perspective to this critical work."
