The Los Angeles Municipal Art Gallery (LAMAG), is pleased to present *ARCHIVE MACHINES*. This online-only juried exhibition brings together recent works by Southern California artists who examine the archive as a conceptual vehicle to decenter singular narratives and encourage plural perspectives through the activities of revisioning, resisting, rewiring, and relating. To do this we invited Los Angeles artists to activate archives by submitting works in response to themes of critical histories, peoples' archives, memory, and institutional critique. Through this exhibition, LAMAG strives to engage with various modes of artistic production that explore how archival structures and materials are appropriated, interpreted, and interrogated.

The juried exhibition brings together 44 artists selected by a jury comprising of **Olivian Cha**, Curator and Collections Manager, Corita Art Center, Los Angeles; **Kerstin Erdmann**, Director, Galería OMR, Mexico City; and **Rita Gonzalez**, Terri and Michael Smooke Curator and Department Head Contemporary Art, LACMA, Los Angeles.

The ARCHIVE MACHINES juried exhibition will debut a format unique from LAMAG's typical web content. The virtual exhibition page will feature highlights of individual artists' work, as well as organizing artworks into four thematic sections to

further engage with artworks and concepts. In further dialogue with archival discourses and the aim to revisit and rethink contexts, the curatorial framework for the presentation of artworks will follow the structure of "living archives," with the exhibition taking a cumulative course, growing throughout the show. The developing nature of the exhibition will also introduce opportunities for visitor participation through the launch of a new, educational salon-style series of topical prompts as a source for community interaction and virtual convening.
